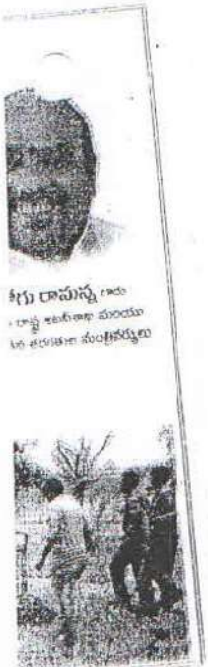

## DOCUMENT NO.1

1. Name of the society : Telangana Brahmin Samkshema Parishad
2. Location of the office : Office of the Commissioner, Endowments, Government of Telangana, Bogulkunta, Hyderabad.
3. Aims and objects : To take up all such activities which promote the welfare of Telangana Brahmin community, including, but not restricted to, the following.

- a) Financial and other support for education and studies - *vedic, smartha, spiritual and secular* - , financial assistance for higher studies abroad, hostel and boarding facilities, skill development, health insurance and benefits, housing, assistance for marriages and other ceremonies, development of entrepreneurship, construction and setting up of community and cultural centres and related infrastructure , libraries, financial assistance and pensions for vedic scholars, aagama pundits and archakas and other needy persons, promotion and support for veda patashalas, Sanskrit institutions, economic support schemes, promotion of art and culture.
- b) To aid, assist, promote, encourage, undertake, coordinate, organize, establish, develop, extend and render financial help and assistance by way of loan or otherwise to the financially and socially weaker and needy members of the Brahmin communities of the state of Telangana; to secure their social betterment, economic development and general up-liftment and to improve their means and standard of living to help and assist them in establishing and setting up business or businesses for the promotion of art, fine art, charity, crafts, religion, sports, literature, culture, science, education including Vedic education, philosophy or diffusion of any knowledge for any public purpose and to help them in agriculture, industrial and tertiary sectors more particularly service sector.
- c) To finance, aid, co-ordinate, organize, secure and provide loans, advances, secured or unsecured, guarantees, securities, and other forms of financial assistance to the eligible members of Brahmin communities for the promotion, establishment and development of projects and schemes to be undertaken, executed and / or assisted in the fields of integrated development of agriculture including land use, irrigation, communication, animal husbandry (especially cows), seed multiplication, nursery pastures, orchard, plant protection service,



agriculture inputs, storage and distribution, manufacture, repair and service centres, agro-processing units and agro-based rural industries.


- d) To provide finance to eligible members of Brahmin community of the State of Telangana by way of lending money with or without security, making advances upon or holding in trust the securities of investments; to promote or assist industrial enterprises; to provide consultancy services including identification of industries to be established, inviting, keeping liaison with intending entrepreneurs, conducting negotiation with bankers and financial institutions on their behalf to secure loans and other assistance, co-ordinating with the State and Central Government and other bodies and agencies both Government and non-Governments, who are engaged on similar objects as of this Society; to jointly act with individuals and organisations for promoting the cause and interest of Brahmin community and their overall development and in particular to create an incubation centre and accelerator fund and develop the entrepreneurial skills of the community and assist start-ups; and to take up all necessary activities in furtherance of and to attain the set objects.
- e) To provide education that builds the character of its future generations; promote Bharatiya heritage; to spread Vedic education among all the communities of the State of Telangana; to establish educational institutions for this purpose; to train and develop skilled personnel for such propagation; to construct facilities for conducting vedic and spiritual discourses and seminars; and to provide Arts as a means to address humanity, promotion of Arts and Culture that helps multi-culture understanding and conflict reduction.
- f) To conduct social outreach programmes in terms of motivational lectures by eminent personalities from different communities and career counselling, skill development programmes and social harmony lectures and activities to reach out to the students irrespective of caste and creed.
- g) The doing of all such other lawful things as considered necessary for the furtherance of the above objects;



## DOCUMENT NO. II

### RULES AND REGULATIONS

1. NAME OF THE SOCIETY : Telangana Brahmin Samkshema Parishad
2. LOCATION OF THE OFFICE & ADDRESS : Office of the Commissioner, Endowments,  
Government of Telangana, Bogulkunta, Hyderabad.
3. (i) MEMBERSHIP : The category and membership of the society shall be as prescribed and nominated/withdrawn by the Government from time to time.  
(ii) CATEGORY OF MEMBERS : Not applicable, as the membership is as per nomination made by the Government.  
(iii) ADMISSION FEE AND THE ANNUAL SUBSCRIPTION OR MONTHLY SUBSCRIPTION : Not applicable, as the membership is as per nomination made by the Government.
4. GENERAL BODY :  
(I) Annual General Body will meet once in a year.  
(ii) FUNCTIONS :
  - a) To pass the budget for the ensuring year and approve the expenditure statement of previous year.
  - b) To approve the reports of the activities of the Society.
  - c) To elect the Executive Committee etc.,
  - d) To appoint Auditor.  
(iii) Society financed by the Government : The Society is being registered in pursuance of the orders issued by the Government,, vide G.O.Ms.No. 267 GA (Cabinet) Dept. dated: 28.01.2017 and is substantially financed by the Government. As such the affairs of the society shall be regulated by the terms, conditions and directions that may be issued by the Government from time to time and the rules and regulations specified hereunder shall be subject to such directions from the Government.
5. (i) Executive Committee : Shall consist of Chairman, Vice-Chairman, Secretary, Treasurer and the three other founder members of the society.  
(ii) The members of the Executive Committee (Governing Body) shall be duty bound to attest the signatures of all the members of the newly elected Executive Committee and to see that the said signatures of the out going Governing Body tally with the annual list as filed with the Registrar of Societies before 15 days the succeeding month in which elections were held.

**(iii) FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS:**

**1. CHAIRMAN :**

He presides over all the meetings of the General Body and Executive Committee. He can cast his vote in the case of a tie in decision making. He can supervise all branches of the Society.

**2. VICE-CHAIRMAN :**

He shall assist the Chairman in discharging his functions. In the absence of the Chairman he will perform the duties of the Chairman as entrusted by him.

**3. SECRETARY :**

He is the custodian of all records relating to the Society and correspondent on behalf of the Society. He will record all minutes of the Society and would convene both the Executive Committee and General Body of the Society with the permission of the Chairman.

**4. TREASURER :**

He has to maintain accounts properly along with the vouchers. He has to prepare the account of the Society. He has to prepare the budget and expenditure statement for submission to the General Body for its approval.

**5. OFFICE BEARERS :**

They are the responsible to attend to such activities of the Society which the Executive Committee may entrust to them.

**6. QUORUM :**

Half of the total members for General Body Meeting and  $\frac{1}{4}$  for Executive Committee Meeting.


**7. FUNDS :**

The funds shall be spent only for the attainment of the objectives of the Society and no portion thereof shall be paid or transferred directly or indirectly to any of the members through any means. Any surplus funds available with the Society shall be invested in such modes as may be specified under Section 11(5) of Income Tax Act from time to time.

(a) **BANK ACCOUNT:** Bank Account or accounts shall be opened in the name of the society and the same shall be operated as may be specified by the Executive Committee from time to time.

(b) The Society shall be eligible to borrow funds from any individual firm, Company, Bank or any other financial institutions with the prior approval of the Government for the purpose of meeting its financial requirements.

(c) The funds of the Society shall constitute the grants received from the Government, donations from various sources, income from its assets, etc.


8. **AMENDMENTS :**

10. None of the office/bearers of the society shall be allowed to use funds or the assets of the society or allowed to derive any benefit either directly or indirectly from the Society as stipulated U/s. 13 (1) (C) of I.T. Act.




