

**MINUTES OF THE EMERGENCY GENERAL BODY MEETING
OF TELANGANA BRAHMIN SAMKSHEMA PARISHAD HELD ON
20.09.2018 AT 11.30 AM IN THE OFFICE THE CHAIRMAN,

At the outset, the Chairman TBSP welcomed the Members to the Emergency General Body meeting of the Parishad and explained that this meeting is called for to discuss various steps to be taken after the issue of approving certain schemes of the Parishad.

**1. CONFIRMATION OF THE MINUTES OF THE LAST
GENERAL BODY MEETING:**

The Minutes of the last General Body meeting held on 10.04.2018 have been read over and confirmed.

2. ACTION TAKEN REPORT ON THE ACTIVITIES OF TBSP:

The following action taken report on the schemes of TBSP has been briefed to the members;

i. Construction of Vipraita Brahmin Sadan:

In the earlier meeting it was observed that in the G.O.Rt.No.584 dt.24.03.2018, there was no mention of Brahmin Sadan and as such resolved to send proposal to

Government. Further it was also resolved that Government be requested for construction of Brahmin Sadans at Districts/ other Urban areas with 75% contribution of cost of construction. Accordingly, Government has been requested vide proposals dated 17.04.2018, the Hon'ble Chairman has informed the Members that Government have cleared both the proposals however prescribing certain procedural norms for construction of Brahmin Sadan at Districts/ Urban areas. As one of the Members raised about 1 acre land donated in Suryapet, Chairman has informed that the construction work would be entrusted to R&B Dept. and soon the proposal would be sent to Government for approval. Further it was also discussed that the land donated should be not less than 1000 Sq.Yds. It should be free from all encumbrances/ litigation, with a confirmation from local Tahasildar to this effect, and be registered in the name of TBSP for processing the proposals. One of the Members requested that the collectors should be addressed to allot Government land in the respective districts for construction of Brahmin Sadans. Chairman assured and instructed the Member Secretary to address the 31 district collectors in this regard. **General Body approved the above proposals.**

ii. **Financial Assistance to Veda Pathasalas:**

In the earlier meeting it was resolved that a proposal has to be sent for converting the one time grant as annual grant. Accordingly, proposals were sent to Government. Hon'ble Chairman has informed the General Body that in

the Government orders dt.18.07.2018, this issue was not mentioned. So, proposals have again been sent to Government in this regard.

iii. **Vedic Students:**

Hon'ble Chairman informed that Government vide Letter No.118/Cabinet/A2/2018 dt.18.07.2018, approved the scheme and that it is being implemented. Further it is also informed that Government have accepted to give Rs.3.00 lakhs to the students studied Smartha and Rs.5.00 lakhs to the students studied Veda while leaving the institution. In this regard, Chairman informed that the said amount can be deposited in the name of students who are pursuing Vedic education in the F.D. account. **General Body approved the same.**

iv. **Veda/Shashtra Pandits Honorarium:**

The Hon'ble Chairman informed that Government have accepted and issued orders to give honorarium of Rs.2,500/- per month to the Veda/ Shashtra pandits who are of 75 years and above. This scheme is being implemented.

v. **Vivekananda Overseas Education:**

The General Body has been informed that this scheme is being implemented as per the norms fixed by Government and amount due to two students whose cases are ratified by Government, has been disbursed.

i. **Lakshya Scheme:**

Chairman has informed that while ratifying the amount already spent (Rs.1,10,000/-) under this scheme Government have directed to discontinue the same.

ii. **Saraswathi Vidya Prashasthi Scheme:**

Chairman has informed that while ratifying the amount already spent (Rs.4,35,000/-) under this scheme Government have directed to discontinue the same.

iii. **Vagdevi Scheme:**

Chairman has informed that while ratifying the amount already spent (Rs.35,000/-) under this scheme Government have directed to discontinue the same.

iv. **Financial assistance to Funerals of poor Brahmin families:**

Chairman has informed that while ratifying the amount already spent (Rs.4,35,000/-) under this scheme Government have directed to discontinue the same.

v. **Health Insurance Scheme:**

Chairman has informed that while ratifying the amount already spent (Rs.47,03,400/- Parishad contribution and Rs.12,06,000/- NIC Ltd. contribution) and amount committed (Rs.1,09,200/-) under this scheme Government have directed to discontinue the same.

vi. **Sampradaya Vidyalaya:**

It was informed by Chairman that Government have agreed to continue this scheme and permitted to give Rs.3.00 lakhs per annum for running this school subject to periodical review. The proposal for paying the amount due for the year 2017-18 is under process.

vii. **Brahmin Entrepreneurial Development Scheme of Telangana:**

Chairman has explained the scheme in its new form and informed the Members that out of 155 cases for which selection letters were given 123 were found to be satisfying basic criteria like Rs.2.00 lakhs and the unit cost between Rs.1 to Rs.12 lakhs. It is further informed that so far 82 cases have been physically verified and out of which 50 (fifty) cases which are clear in all respects, have been approved in the first phase and the rest would be verified, processed and eligible cases will be approved very soon. The members have suggested the distribution of cheques to the eligible beneficiaries through Hon'ble C.M. or Minister by conducting a programme. **General Body unanimously accepted the proposal.**

viii. **Pragnya Development Scheme:**

Chairman has informed that while ratifying the decision of the Parishad in imparting skill and giving placement to the unemployed Brahmin Youth through Golar Networks and Apollo Medi Skills, Government directed to discontinue this scheme duly paying the amount claimed by the aforementioned two firms duly verifying the same

through third party. Chairman has informed that the third party verification has been entrusted to Society for Social Audit, Accountability and Transparency, Department of Rural Development Telangana, Hyderabad and that the verification work would be completed by the end of this month.

To read and record Letter No.118/Cabinet/A2/2018 dated 18.07.2018 (Annexure-II):

The Chairman has read over the contents of the Letter No.118/Cabinet/A2/2018 dt.18.07.2018.

- i. As per the note dated 08.08.2018 received from the Hon'ble Chairman an amount of Rs.3.00 lakhs was released vide Cheque No. 000258, dated 10.08.2018 in favour of Telangana Vidvath Sabha on the occasion of Telangana Rastra Jyotisha Maha Sabhalu held on 13.08.2018 and 14.08.2018. **The action taken by the TBSP has been ratified by the General Body.**
- ii. General Body has unanimously endorsed to sanction and to draw an amount of Rs.2.00 lakhs to meet incidental Expenditure during the proposed Job Mela on 30.09.2018.
- iii. General Body has taken note of the resignation of Sri C.L. Rajam, Trasurer of TBSP and its approval by Government.
- iv. The General Body unanimously passed resolution condoling the demise of Brahma Sri Kodakandla

Nrusimha Sharma, Shastra pandit who received honorarium from Brahmin Parishad.

Action Plan for the year 2018-19

The action plan (as shown in Annexure-I) for the year 2018-19 for implementation of the schemes and to meet the Administrative expenditure has been approved by the General Body.
