

MINUTES OF THE EXECUTIVE COMMITTEE MEETING OF TELANGANA BRAHMIN SAMKSHEMA PARISHAD HELD ON 28.04.2022 AT 11.30AM IN THE OFFICE OF THE CHAIRMAN, TELANGANA BRAHMIN SAMKSHEMA PARISHAD, DHARMIK BHAVAN, BOGGULAKUNTA, ABIDS, HYDERABAD.

At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss certain agenda items and the following deliberations held.

1. Confirmation of The Minutes of The Last Executive Committee Meeting:

The Minutes of the last Executive Committee meeting held on 07.03.2022 have been read over and confirmed.

2. Construction of Viprahita Brahmin Sadan:

The photographs of Brahmin Sadan exhibited in the Agenda have been perused by Executive Committee members and expressed concern for its early completion. The members have urged to pursue with R & B Department and to get the construction completed as expeditiously as possible. Further, the Executive Committee opined that it would be better to get the Brahmin Sadan Building at Gopanpally completed in all respects so that same could be inaugurated in the month of May, 2022.

3. Brahmin Entrepreneurship Scheme of Telangana (BEST):

The Executive Committee have been informed about the status of applications received under the scheme. They have been informed that in the last Executive Committee meeting a list of as many as (425) beneficiaries has been approved and the proposals have been submitted to the Government for disbursement of Rs. 12,81,43,304/- (Rupees Twelve crores eighty one lakhs forty three thousand three hundred and four only). The Executive Committee have been informed that the proposals were pending in the Finance Department and was being pursued regularly for clearance.

Further, a fresh proposal containing the list of 461 beneficiaries for which physical verification was completed has been placed before the Executive Committee for approval. The Committee have approved the list of (461) beneficiaries and accorded permission for disbursement of Rs. 13,99,76,358/- (Rupees Thirteen crores ninety nine lakhs seventy six thousand three hundred and fifty eight only) for the said beneficiaries duly following the norms.

4. Vivekananda Overseas Education Scheme:

The Executive Committee members have been informed that in this year as many as (235) applications have been received and all the applications have been processed in two spells and in the 1st spell (100) applications were processed and in the 2nd spell balance (135) applications have been processed. Recommendations of Selection Committee for 1st spell have

already been approved by Executive committee in the meeting held on 07.03.2022.

The Executive Committee have been informed that with regard to 2nd spell of interviews the recommendations of the Selection Committee were now placed before the Executive Committee for approval as detailed below:

The Executive Committee have accorded permission to give provisional sanction letters to all the eligible (69) beneficiaries selected during 2nd phase.

The Committee opined that as many as (62) beneficiaries who got approval in the last Executive Committee meeting held on 07.03.2022 and the (69) beneficiaries who got approval in this meeting and those deferred cases wherein the candidates have subsequently submitted requisite documents, can be given provisional sanction letters by organizing a function in the 3rd or 4th week of the May, 2022 duly inviting one of the distinguished public representatives for distribution of sanction letters.

5. Financial Assistance to Brahmin aspirants for coaching in respect of competitive exams:

The Executive Committee have been informed that as per the resolution passed in the General Body Meeting held on 30.03.2022, a proposal vide D.O. Lr. No. Nil, dated: 11.04.2022 had been sent to the Chief Secretary to the Government of Telangana seeking permission to tie-up with BC Welfare Department for imparting coaching to the job aspirants among the Brahmin unemployees in the BC study circles situated at various District Head Quarters in the state, and also to accord permission to provide stipend @ Rs.5,000/- per month to each candidate who undergoes coaching for Group-I services and Rs. 2,000/- per month for those aspirants for other services.

The Government in consultation with BC Welfare Department agreed the proposals of Telangana Brahmin Samkshema Parishad vide Memo No. 13/Cabinet/A2/2022, Dated: 28.04.2022. The orders of Government have been informed to the members of Executive Committee, and discussed the modalities with which the said scheme should be taken forward. The Executive Committee members have expressed happiness in this matter and authorized Chairman, TBSP to go ahead with this scheme as per norms and modalities discussed and also as per the order of government from time to time; if any.

6. Action Plan for the Financial Year 2022-23:

The Action Plan for the Financial Year 2022-23 is placed before the Executive Committee for approval and the same has been approved.

However, the Chairman, TBSP is authorized to reappropriate from one scheme to the other, depending upon the need/priority, as the case may be.
