ORDER:

In the reference 2nd read above, while reviewing the progress of activities undertaken by the Telangana Brahmin Samkshema Parishad constituted vide reference 1st cited, Hon'ble Chief Minister had approved introduction of certain schemes for welfare of the Brahmin community in Telangana State.

2. Accordingly, Government after careful examination of the matter, hereby approve the following schemes:

1. **Vivekananda Overseas Education Scheme:** This scheme will enable Brahmin students to pursue the professional and other higher educational courses abroad, who were hitherto not able to make it due to financial constraint. The income, age limit, qualification and the scholarship amount for this purpose will be on par with the schemes namely Ambedkar Overseas Vidyanidhi meant for SC and ST students & as revised from time to time.

2. **Ramanuja Scheme** for fee reimbursement of the students from Brahmin families belonging BPL are covered under EBC category. Telangana Brahmin Samkshema Parishad will extend financial assistance to the Brahmin students from BPL families to continue their education duly reimbursing the admission fee as prescribed by the Government from time to time for other students who are pursuing regular courses of higher studies.

Grant to Veda Patasala: Financial incentive of one time grant of maximum of Rs.2 lakhs (Rupees Two lakhs only) will be extended to each of the Veda Patasalas subject to establishing their credentials, bonafide purpose and accountability towards society.

3. The Member Secretary 'Telangana Brahmin Samkshema Parishad' shall take necessary action.


