At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss various steps to be taken after the issue of approval for certain schemes of the Parishad.

**1. CONFIRMATION OF THE MINUTES OF THE LAST  
EXECUTIVE COMMITTEE MEETING:**

The Minutes of the last Executive Committee meeting held on 01.03.2021 have been read over and confirmed.

**2. Construction of Viprahita Brahmin Sadan:**

The Executive Committee have been informed of the latest stage of construction of Brahmin Sadan at Gopanpally (V) of Rangareddy District.

In the last meeting, Executive Committee has opined that the some staff members are required for the maintenance of the Brahmin Sadan at Hyderabad after completion of construction.

In this regard a letter has been sent to Government; suitably drafted.

### **3. Brahmin Entrepreneurial Development Scheme of Telangana:**

The Executive Committee have been informed that (380) cases which were approved in the last Executive Committee Meeting have been processed and subsidy amounts have been disbursed to their respective bank accounts.

Further, (270) cases in respect of which physical verification is completed have been placed before the Executive Committee for approval to disburse subsidy amount to a tune of Rs.6,96,18,959/- (Rupees Six crores ninety-six lakhs eighteen thousand nine hundred and fifty-nine only). The Executive Committee have perused and approved the proposal with a direction to disburse the subsidy amounts into the bank accounts of beneficiaries as per the usual procedure.

### **4. Vivekananda Overseas Education Scheme:**

The Executive Committee have ratified the issuance of sanction letter to one Mr. **Gogulapati Akhil Srivatsav** S/o Sri G.Krishna Mohan whose case was deferred for want of certain documents, which have been submitted recently.

Further, in the last meeting, Executive Committee has resolved to send a proposal to Government to relax the rule to pursue the Master's/P.G/Ph.D. courses in foreign Educational Institutions for the 2<sup>nd</sup> person in a family after a gap of three (3) years from the date of sanction of the benefit to the 1<sup>st</sup> person. In this regard a letter has been sent to Government; suitably drafted.



#### **5. Sri Ramanuja Scheme:**

The Executive Committee have approved the proposal for reimbursing the fee to (04) fresh applicants and (14) renewed applicants who have fulfilled the requirements as per existing guidelines.

#### **6. Sampradaya Patashala:**

For the year 2020-21 the management of Sampradaya patashala submitted proposals to the Brahmin Parishad for issuance of annual grant of Rs.3.00 Lakhs. The Executive Committee has resolved to sanction the same and requested the administrator to visit the patashala and report to the Chairman before releasing the grant.

#### **7. Financial Assistance to Sadguru Sadan Trust, Cheryala:**

Sadguru Sadan Trust , Cheryala has informed that they are constructing Sadguru Sadanam for the use of Brahmin families residing in the mandals of Cheryala, Komravelli, Madduru, Dhulimitta, Tarigoppula and Narmetta of Siddipet District. They have completed 80% of construction of building with special development fund. They have requested to sanction an amount of Rs.40.00 lakhs to complete the remaining pending works.

The issue has been discussed in detail in the Executive Committee meeting and Sri R. Kondal Rao EnC(Retired) and Advisor,TBSP has been requested to inspect the building and submit the report for taking further necessary action.

#### **8. Action- Plan for the financial year 2021-2022:**

The Executive Committee have been informed that for the Financial Year 2021-22, the government have allocated

Rs.50.00 Crores (Rupees Fifty Crores) under the head of Brahmin Welfare fund. Considering the availability of budget and funds, an Action- plan has been prepared and placed before the Executive Committee. Earmarking of funds basing on the requirement under each welfare scheme is shown in the said Action-plan. The Executive Committee have perused and approved the Action-plan. The Hon'ble Chairman, TBSP is authorized to reappropriate the funds from one scheme to another as per the requirement, if necessary.
