

**MINUTES OF THE EXECUTIVE COMMITTEE MEETING
OF TELANGANA BRAHMIN SAMKSEMA PARISHAD
HELD ON 01.03.2021 AT 11.30 AM IN THE OFFICE

At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss various steps to be taken after the issue of approving certain schemes of the Parishad.

**1. CONFIRMATION OF THE MINUTES OF THE LAST
EXECUTIVE COMMITTEE MEETING:**

The Minutes of the last Executive Committee meeting held on 19.12.2020 have been read over and confirmed.

2. Construction of Viprahita Brahmin Sadan:

The Executive Committee have been informed of the latest stage of construction of Brahmin Sadan at Gopanpally (V) of Rangareddy District. The Committee has tentatively fixed the date for inauguration of the Brahmin Sadan on the occasion of Sri Ramanavami on 21.04.2021.

- The Executive Committee has opined that the following staff is required to maintain the Brahmin Sadan at Hyderabad after completion of construction.

- The Executive Committee duly approving the above pattern requested the Member Secretary to send a proposal to the Government for sanction of the above said posts.
- In respect of construction of Brahmin Sadan at Suryapeta, the Government have accorded administrative sanction to a tune of Rs.200.00 lakhs (Rupees Two hundred lakhs only) vide G.O.Rt.No.55 General Administration (Cabinet) Department, dated 06-01-2021. The District R & B Officer, Suryapet has been addressed to take up construction work of Brahmin Sadan by calling Tenders. The Executive Committee took note of the same.
- The members of Executive Committee have enquired about the status of land at Gajwel, Siddipet District. The Chairman has informed the members that the land

proposed to be donated is not yet registered in favour of Telangana Brahmin Samkshema Parishad for construction of Brahmin Sadan. The Executive Committee has requested the Member Secretary, Telangana Brahmin Samkshema Parishad to issue a show cause notice to the Secretary, Gajwel Brahmin Seva Sangham, Siddipet District as to why not to cancel the sanction orders issued in the General Body Meeting held on 15.02.2017; since no proper response nor adequate interest is shown inspite of a lapse of four years.

- The Executive Committee have also ratified the action of Chairman, TBSP regarding the extension of services of Sri R. Kondala Rao, Engineer-in-chief (R) for one more year with effect from 20-01-2021 to guide us on technical issues relating to Brahmin Sadans.

3. Brahmin Entrepreneurial Development Scheme of Telangana:

The Executive Committee have been informed that (390) cases which were approved in the last Executive Committee Meeting have been processed and subsidy amounts have been disbursed to their respective bank accounts.

Further, proposal of 380 (Three hundred and eighty) cases in respect of which physical verification is completed have been placed before the Executive Committee for approval to disburse subsidy amount to a tune of Rs.9,97,31,770/- (Rupees Nine crores ninety seven lakhs thirty one thousand seven hundred and seventy only). The Executive Committee have perused and approved the proposal with a direction to

disburse the subsidy amounts into the bank accounts of beneficiaries as per the usual procedure.

4. Vivekananda Overseas Education Scheme:

The Executive Committee have been informed that the Selection Committee had interviewed (53) fresh applicants under Vivekananda Overseas Education scheme from 18.01.2021 to 21.01.2021 and recommended 33 (Thirty three) cases for issuing sanction letters. The Executive Committee have approved the proposal to issue sanction letters to the (33) recommended cases.

- Further the Executive Committee have approved the proposal regarding issuance of sanction letter to one Mr. **Pemmaraju Abhishek** Rao S/o Sri Krishna Rao whose case was deferred for want of certain documents, which have been submitted recently.
- Executive Committee has gone through the details in respect of **Sri Kondapalli Sai Srinivasa Sudarshan** and requested the Member Secretary to consider his case favorably, provided that the father of the applicant returns the subsidy amount received from Telangana Brahmin Samkshema Parishad and if he is eligible in all other respects as per existing norms and rules.
- As regards deferred candidates, the Executive Committee perused the recommendations of the selection committee in each case and approved the same duly instructing to help them out duly advising the applicants, whatever necessary, within the parameters of Government's guidelines.

- Further, the Executive Committee has resolved to send a proposal to Government to relax the rule to pursue the Master's/PG /Phd. courses in foreign Educational Institutions for the 2nd person in a family after a gap of (3) years from the date of sanction of the benefit to the 1st person.

5. Sri Ramanuja Scheme:

The Executive Committee have approved the proposal for reimbursing the fee to 10 (ten) fresh applicants and 9 (nine) renewed applicants who have fulfilled the requirements as per existing guidelines.

6. Veda Hita- Veda Patahala:

The Executive Committee have approved the recommendations of Vedic Committee for giving Rs.2.00 lakhs (Rupees Two Lakhs only) to the Veda patashala by name "Medha Samvardhini Educational Trust, Parvathagiri (V &M), Warangal (Rural) District.

7. Veda Hita- Veda/ Sastra Pandits:

The Executive Committee has approved the recommendations of Vedic Committee for sanctioning honorarium of Rs.2500/- (Rupees Two thousand five hundred only) per month to the following Veda/Sastra pandits of above 75 years of age w.e.f February,2021.

1. Sri.Patwari Gopal Kishan Rao (75), Paspul (V), Makthal (M),Narayanpet District.
2. Sri Avunoori Ramkishan Rao (78), Siddipet (V &M), Siddipet District.
3. Sri Gangadara Rajeshwara Sharma (76), Mittapalle(V), Siddipet Urban (M), Siddipet District.

8. Audit & Accounts:

The Statement of Audited accounts for the Financial Year 2019-20 is placed before the Executive committee for approval and the same has been approved.

- The Committee has ratified the action of Chairman, Telangana Brahmin Samkshema Parishad for having sanctioned Rs.1,000/- (Rupees one thousand Only) per month as transport Allowance to Sri B. Kiran Kumar, Office Subordinate on par with other Outsourcing staff members w.e.f 01.12.2020.
