

**MINUTES OF THE EXECUTIVE COMMITTEE MEETING OF TELANGANA BRAHMIN SAMKSHEMA PARISHAD HELD ON 10.06.2022 AT 11.30AM IN THE OFFICE OF THE CHAIRMAN, TELANGANA BRAHMIN SAMKSHEMA PARISHAD, DHARMIK BHAVAN, BOGGULAKUNTA, ABIDS, HYDERABAD.**

At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss certain agenda items and the following deliberations held.

**1. Confirmation of the Minutes of the Last Executive Committee Meeting:**

The Minutes of the last Executive Committee meeting held on 28.04.2022 have been read over and confirmed.

**2. Construction of Viprahita Brahmin Sadan:**

The photographs of Brahmin Sadan exhibited in the Agenda have been perused by Executive Committee members and expressed concern for its early completion. The members have urged to pursue with R & B Department and to get the construction completed as expeditiously as possible. Further, the Executive Committee opined that it would be better to get the Brahmin Sadan Building at Gopanpally completed in all respects so that the same could be inaugurated soon.

**3. Brahmin Entrepreneurship Scheme of Telangana (BEST):**

The Committee has been informed that in the last meeting Executive Committee have approved a list of 461 beneficiaries and accorded permission for disbursement of Rs. 13,99,76,358/- for the said beneficiaries, and that the disbursement of subsidy is under progress duly confirming the 40% contribution from beneficiaries.

Further, a fresh proposal containing the list of (182) beneficiaries for which, physical verification was completed has been placed before the Executive Committee for approval. The Committee have approved the list of (182) beneficiaries and accorded permission for disbursement of Rs. 6,01,56,413/- (Rupees Six crores One lakh Fifty Six thousand Four hundred and Thirteen only) for the said beneficiaries duly following the norms.

#### **4. Vedahita-Honorarium to Veda/Shashtra Pandits:**

Under the scheme one (1) application has been received with the recommendation of the Vedic Committee headed by Sri Ashtakala Rammohan Rao, Member, TBSP. The details are as follows:

Sri Srinivasula Janardanacharyulu, aged, 75 years, Madhira (V & M), Khammam (D). The proposal is placed before the Executive Committee for approval of sanctioning of monthly honorarium and the same was approved.

#### **5. Construction of Apra Karma Bhavans at Khammam/Madhira:**

The Executive Committee has been informed that the Government have accorded permission for construction of Apra Karma Bhavans at Khammam and Madhira Towns and that the follow up action was being taken. Executive Committee have opined that the date for Bhoomi Pooja could be fixed soon duly consulting the representatives of local Brahmana Sanghams who are actively pursuing the matter. A special request has been made to Vice Chairman, TBSP in this regard.

#### **6. Financial Assistance to Sadguru Sadan at Cherial:**

The Executive Committee has been informed that, in Cherial of Siddipet (D), Sadguru Sadan is under construction by Sadguru Sadan Trust which is meant for the welfare of local Brahmin community.

Further it was informed that the President of Sadguru Sadan Trust submitted a representation seeking financial assistance for completion of balance works, for which they had no funds. His request has been examined with reference to Brahmin Sadan scheme and got the cost of balance works estimated @ Rs. 20.00 lakhs.



The Executive Committee was requested to recollect the formal discussion held in this matter in the last meeting and placed the proposal for their approval in order to send an appropriate proposal seeking permission of the Government, for releasing Rs.20.00 lakhs in favour of said trust to complete the balance works. The Executive Committee have approved the said proposal.

**7. Financial Aid for Coaching to the Job aspirants:**

Further, it was brought to the notice of Executive Committee that in response to Telangana Brahmin Samkshema Parishad notification with regard to importing coaching and supplying study material to the job aspirants who are preparing for competitive exams through B.C. Study circles, as many as (148) candidates have applied and out of which 98 persons have joined. Out of these 98 persons 89 candidates are taking coaching for Group-I Preliminary Exam.

Further it was informed that the Director, B.C. Study circle has submitted proposal to sanction stipend of Rs. 5,000/- to each candidate and to disburse the same through Electronic Clearance Service (ECS).

The Executive Committee have approved the proposal and opined that out of Rs. 5,000/- as much as Rs. 2,000/ should be earmarked for study material and the rest should be for the transportation and other miscellaneous/personal expenditure incurred for coaching by the candidate along with payment of cost of coaching per candidate for three months to be paid to BC Welfare Department/Corporation as requested for.
