MINUTES OF THE EXECUTIVE COMMITTE MEETING OF TELANGANA BRAHMIN SAMKSHEMA PARISHAD HELD ON 17.06.2020 AT 11:30 AM IN THE OFFICE THE CHAIRMAN, TELANGANA BRAHMIN SAMKSHEMA PARISHAD, DHARMIK BHAVAN, BOGGULAKUNTA, ABIDS, HYDERABAD.

At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss various steps to be taken after the issue of approving certain schemes of the Parishad.

1. CONFIRMATION OF THE MINUTES OF THE LAST EXECUTIVE COMMITTE MEETING:

The Minutes of the last Executive Committee meeting held on 08.01.2020 have been read over and confirmed.

2. Construction of Viprahita Brahmin Sadan:

The Executive Committee have been informed of the latest stage of construction of Brahmin Sadan at Gopanpally (V) of Rangareddy District.

Construction of Brahmin Sadans at Districts:

The Executive Committee have been informed that the proposals sent by Telangana Brahmin Samkshema Parishad to Government for according permission to share 75% cost of construction in respect of following (3) Brahmin Sadans have

not yet been cleared from Government and Parishad is pursuing the matter regularly.

- 1) Apara karma bhavan at Khammam town in extent of 475 Sq. Yards with a total cost of Rs.75.00 lakhs as estimated by District R & B officer Khammam.
- 2) Apara karma Bhavan at Madhira town in an extent of 208.90 Sq. Yards with a total cost of Rs.73.00 lakhs as estimated by District R & B officer Khammam.
- 3) Renovation of Brahmin Sadan at Siddipet town at a cost of Rs.97.40 lakhs.

3. Vivekananda Overseas Education Scheme:

The Executive Committee have been informed that all the (58) candidates who have been selected by the Selection Committee and approved by the Executive Committee in the meeting held on 08-01-2020 have been given sanction letters and the scholarship amount is getting disbursed on par with the cases sanctioned hitherto.

Further, the Executive Committee have been informed that the Selection Committee had interviewed the (104) fresh applicants under Vivekananda Overseas Education scheme from 08-06-2020 to 12-06-2020 and recommended (57) cases for issuing sanction letters. The Executive Committee have approved the proposal to issue sanction letters to the (57) recommended cases.

4. Brahmin Entrepreneurial Development Scheme of Telangana:

Under this scheme, the Executive Committee have been informed that in respect of (208) cases which were approved in the last meeting, the subsidy amount (Rs.5,88,42,580/-) has been disbursed by depositing the same into respective bank accounts of beneficiaries.

Further, the recommendations of Selection Committee with regard to (241) cases in respect of which physical verification has been completed, have been placed before the Executive Committee for giving approval. The Executive Committee have approved these cases. Besides these (241) cases, the Executive Committee discussed about the application of Sri Mahavadi Santhosh R/o.12-257, Gouthami Nagar, Mancherial and approved his case, subject to change of trade.

The Executive Committee have directed to disburse the subsidy amount of Rs.6,67,82,650/- by depositing the same into the beneficiaries' bank accounts.

5. Sri Ramanuja Scheme:

The Executive Committee have approved the proposal for reimbursing the fee to as many as (69) students who have fulfilled the requirements as per existing guidelines.

6. Veda/Shastra Pandits Honororium:

The Executive Committee approved the recommendations of the Vedic Committee with regard to sanction of honororium @ Rs.2,500/- per month in favor of Sri Thiramal Rao Bibipet (78), Janagaon (V), Bibipet (M), Kamareddy (D).

7. Grant to Veda Patashala:

The Executive Committee have approved the recommendations of Vedic Committee for giving Rs.2.00 lakhs (Rupees Two Lakhs only) to the Veda Patashala by name

Sri Venkata Saandeepa Veda (Pravardhaka)Vidyalayam, Tirumala Gardens, Near Bachpan School, Bandlaguda Jageer, Rangareddy District, wherein as many as (10) students are learning Vedic education.

8. Request of Dhanvantari Foundation:

The Executive Committee have been informed that the proposals sent to Government to accord permission for contributing Rs.50,000/- to each candidate who is taking coaching to get through Civil Services exam conducted by UPSC, in the institution run by Dhanvantari Foundation, have been returned on the ground that the financial year 2019-20 was closed. Further, the executive committee have been informed that the proposal had been re-submitted with a request to process the file during the current financial year 2020-21.

9. Vedahitha - Sustenance allowance:

The Executive Committee have been informed of the status of this scheme and the extent of funds required for its implementation. The Executive Committee have opined that the factual position be brought to the notice of the Government at the earliest.

10. Audit And Accounts

The statement of Audited accounts for the Financial Year 2018-19 is placed before the Executive Committee for approval and the same has been approved.

Action with regard to undisposed cases:

Apart from the above, the Executive Committee has been informed of the number & status of applications received during the period from 27-01-2020 to 31-03-2020 under various schemes. The Executive Committee have expressed concern about the cases under BEST scheme which are due for physical verification. It is brought to the notice of Executive Committee that the pandemic situation prevailing in the state does not allow the staff to conduct physical verification of beneficiaries by visiting door to door. Then the committee suggested to examine the feasibility of conducting verification through video conference. The suggestion has been well-taken and informed the Committee that the feasibility of video conference would be explored duly consulting IT experts.
