MINUTES OF THE EXECUTIVE COMMITTE MEETING OF TELANGANA BRAHMIN SAMKSHEMA PARISHAD HELD ON 31.07.2021 AT 11.30AM IN THE OFFICE OF THE CHAIRMAN, TELANGANA BRAHMIN SAMKSHEMA PARISHAD, DHARMIK BHAVAN, BOGGULAKUNTA, ABIDS, HYDERABAD.

At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss Certain agenda items and the following deliberations held.

1.CONFIRMATION OF THE MINUTES OF THE LAST EXECUTIVE COMMITTE MEETING:

The Minutes of the last Executive Committee meeting held on 27.04.2021 have been read over and confirmed.

2. Construction of Viprahita Brahmin Sadan:

The Executive Committee have been informed of the latest stage of construction of Brahmin Sadan at Gopanpally (V) of Rangareddy District.

Staff proposals for maintenance of Brahmin Sadan have been sent to Government. Reply is awaited in this regard. Member Secretary, TBSP is requested to takeup effective follow-up action in this regard.

3. Brahmin Entrepreneurial Development Scheme of Telangana:

The Executive Committee have been informed that (270) cases which were approved in the last Executive Committee Meeting have been processed and subsidy amount has been disbursed to their respective bank accounts.

Further the Executive Committee have ratified the decision of processing and disbursement of subsidy to as many as (16) cases which were kept on hold for want of requisite documents, later they submitted the relevant documents.

Further, (250) fresh cases in which physical verification is completed have been placed before the Executive Committee for approval to disburse subsidy amount to a tune of Rs.6,85,55,521/- (Rupees Six crores eighty-five lakhs fifty-five thousand five hundred and twenty-one only). The Executive Committee have perused and approved the proposal with a request to disburse the subsidy amounts into the bank accounts of beneficiaries as per the guidelines.

4. Vivekananda Overseas Education Scheme:

The Executive Committee have perused the recommendations of selection committee in respect of (100) one hundred applicants who were interviewed from 22-06-2021 to 25-06-2021 and approved the list of (62) sixty two shortlisted applicants and requested the Member Secretary to issue Provisional Selection letters.

Due to the pandemic situation lock down was enforced all over the world and also the travel ban has been continuing in such countries like Canada, Australia, New Zealand & UK, etc., As the flights were suspended, the applicants were not able to

reach the aforementioned countries with in the stipulated time. This kind of circumstances were not at all thought of while issuing the relevant G.O's under this scheme.

In view of the above, the Executive Committee had discussed in its meeting on aforementioned issues. In this regard, the Executive Committee members have requested to the Member Secretary, TBSP to ascertain the information from SC Development Department on the following issues. Accordingly, the Member-Secretary has ascertained the following procedure from the S C Development Department in respect of the issues discussed in the Executive Committee meeting, under Ambedkar Overseas Vidya Nidhi Scheme (AOVN). The gist of the issues, flagged and the procedure to be implemented is mentioned below item wise.

i. Changing the universities/courses/Countries:

An internal file will be circulated to the Chairman, State Level Selection Committee (SLSC). After approval of the Chairman, SLSC, a revised sanction letter will be given to the applicants.

ii. Expiry of provisional selection letter:

As per G.O. Ms. No. 54; dated:28.03.2013 SOCIAL WELFARE (EDN.2) DEPARTMENT, Once selection letter issued to the applicant no changes will be entertained. "The selected candidate has to join the concerned university within one year of communication of selection. On expiry of this specified period of time, the award will be automatically cancelled and come to an end. No request for extension of time for availing the award is permissible under the Scheme".

In this regard, the representations received from the applicants who have been provisionally shortlisted and got selection letters which got expired due to some reasons will be placed before the State Level Selection Committee (SLSC). After approval by the selection committee a revised provisional selection letter will be issued to the applicants.

iii. Attending online classes from India:

As per G.O. Ms. No. 54; dated:28.03.2013 SOCIAL WELFARE (EDN.2) DEPARTMENT, subject to production of the landing permit / I-94 card. (Immigration Card) the first instalment will be disbursed to the applicants. The same is being practised by the SC development Department also.

In respect of i, ii & iii, the procedure suggested is approved as is being done in other similar Welfare Corporations/

iv. One Family-One Benefit:

The internal policy 'One Family-One Benefit' was adapted by Telangana Brahmin Samkshema Parishad, with a broader view to benefit all brahmin families and not to favor any family with multiple benefits. The Executive Committee have discussed on the said issue elaborately and finally the committee have opined that the Brahmin Entrepreneurial Scheme of Telangana (BEST) is meant for the parents for their economic upliftment, whereas the Vivekananada Overseas Education Scheme (VOES) was designed to help the students who want to pursue their Master's/Post Graduation courses in abroad. The intention of both the schemes are different and it is observed that as ascertained from the SC Development Department, no such

restrictions are there while sanctioning of the scholarship under Ambedkar Overseas Vidya Nidhi (AOVN).

After detailed discussion, the Executive Committee have resolved that Telangana Brahmin Samkshema Parishad may also follow the practice followed in other similar Welfare Departments/Corporation in this regard.

5. Sri Ramanuja Scheme:

The Executive Committee have approved the proposal for reimbursing the fee to (07) fresh applicants and (15) renewed applicants who have fulfilled the requirements as per existing guidelines.

The Executive Committee have opined that the students who are pursuing post metric courses, outside Telangana State in premier institutes like IIT's, IIM's etc., may also be considered under this scheme. In this regard it is resolved to address the Government for consideration of reimbursement of tuition fee to such students who are pursuing their studies outside Telangana State under this scheme.

6. Annual grant of Sampradaya Patashala:

The Executive Committee have approved the sanction of annual grant of Rs.3,00,000/- to the account of Prathyaksha Charitable Trust for the financial year 2020-21.

7. Vedahita - Honororium to - Veda/Sastra pandits:

The recommendations of Vedic Committee with regard to sanctioning of monthly Honororium @ 2,500 to (09) Veda/Sastra pandits, namely
