

MINUTES OF THE EXECUTIVE COMMITTEE MEETING OF TELANGANA BRAHMIN SAMKSEMA PARISHAD HELD ON 15.11.2021 AT 11.30AM IN THE OFFICE OF THE CHAIRMAN, TELANGANA BRAHMIN SAMKSEMA PARISHAD, DHARMIK BHAVAN, BOGGULAKUNTA, ABIDS, HYDERABAD.

At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss certain agenda items and the following deliberations held.

1. CONFIRMATION OF THE MINUTES OF THE LAST EXECUTIVE COMMITTEE MEETING:

The Minutes of the last Executive Committee meeting held on 31.07.2021 have been read over and confirmed.

2. Construction of Viprahita Brahmin Sadan:

The Executive Committee have been informed of the latest stage of construction of Brahmin Sadan at Gopanpally (V) of Rangareddy District.

3. Brahmin Entrepreneurial Development Scheme of Telangana:

The Executive Committee have perused and approved as many as (250) cases for disbursement of subsidy to a tune Rs.6,85,55,521/- (Rupees Six Crores Eighty-Five Lakhs Fifty-Five Thousand Five Hundred and Twenty-One only). Out of (250) cases as many as (173) applicants have deposited their individual contribution in their bank accounts and submitted the copies of bank statements. The matching grant i.e., subsidy to a tune of Rs.4,85,74,664/- (Rupees Four crores eighty five lakhs seventy four thousand six hundred and sixty four only) has been deposited in to the individual bank accounts of the beneficiaries.

Further the Executive Committee have ratified (92) applicants which was discussed in earlier committee meeting and selected for the matching grant subsidy to a tune of Rs.2,95,20,650/- (Rupees Two crores ninety-five lakhs twenty thousand six hundred and fifty only). All these beneficiaries were requested to submit their bank statements duly depositing their contribution. It is under process.

Further, (226) fresh cases in which physical verification is completed have been placed before the Executive Committee for sanction of matching grant subsidy amount to a tune of Rs.7,72,65,031/- (Rupees Seven Crores Seventy Two lakhs Sixty Five Thousand Thirty one only). The Executive Committee have perused and approved with a request to disburse the matching grant amount into the bank accounts of beneficiaries as per the guidelines.

4. Vivekananda Overseas Education Scheme:

As discussed in the earlier Executive Committee meeting the following applications were kept on hold for non-submission of certain documents which were essential to consider their cases. The names of the applicants are as follows.

6. Vedahita –Stipend to vedic students:

Under this scheme, as many as (02) applications have been received through online, namely

The Executive Committee have perused and approved the same.

Further it is submitted that the Government have given the following stipulations for promoting Vedic studies in addition to payment of Rs.250/- per student/per month as a stipend.

❖ **Payment of Rs.3.00 lakhs after successful completion of Smartha studies and Rs.5.00 lakhs after successful completion of Agama, Kramantha and Gananthaas sustenance grant duly prescribing the norms and standards as followed by the TTD.**

In this connection, the Hon'ble Chairman has brought to the notice of the Executive Committee members that the non-implementation of sustenance allowance to the students who completed their vedic education in Smartha/ Agama, Kramantha and Ghanantha which was already approved by the Government. **But due to paucity of funds the payments have not been made so far.**

Keeping in view of the above it is resolved to submit a proposal to Government for consideration for sanction of funds up to Rs. 100.00 crores to Telangana Brahmin Samkshema Parishad, so as to enable it to implement this scheme for the welfare of vedic students .
