At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss various steps to be taken after the issue of approving certain schemes of the Parishad.

**1. CONFIRMATION OF THE MINUTES OF THE LAST  
GENERAL BODY MEETING:**

The Minutes of the last General Body meeting held on 29.05.2019 have been read over and confirmed.

**2. i. Construction of Viprahita Brahmin Sadan:**

The Executive Committee have been informed that the construction of Viprahita Brahmin Sadan at Gopanpally (V), Serlingampalli (M), Rangareddy (D) was going on at brisk pace, the 3 structures relating to 1. Information Centre 2. Seers Accommodation Block 3. Toilet Block were almost completed and plastering work was going on and the same would be finished in full shape by August 2019.



Further the Executive Committee has also been informed that Executive Engineer (R&B) concerned had informed that for construction of Kalyana Mandapam, the tender process was under finalisation. The Executive Committee took note of the same and instructed to pursue the matter on regular basis.

**ii. Construction of Apari Karma Bhavan:**

The proposal of Madhira Brahmin Sangham for construction of Apari Karma Bhavan at Madhira town, Khammam District was placed before the committee for approval. The committee approved the same.

**3. Brahmin Entrepreneurship Development Scheme of Telangana:**

The Executive Committee have been informed that all the 175 (One hundred and Seventy five) beneficiaries whose cases were approved in the last Executive Committee meeting dt.29-05-2019 have been disbursed with the subsidy amount to a tune of Rs.4,86,83,740/- by transferring the amount into their respective bank accounts.

The Executive Committee have also been informed that so far an amount of Rs.16,05,90,152/- has been disbursed to as many as 536 (Five hundred and thirty six) beneficiaries under this scheme.

Further, the Executive Committee have given approval for disbursement of subsidy to a tune of Rs.5,55,43,975/- to 159 (One hundred and fifty nine) beneficiaries, whose cases were physically verified by the staff of TBSP in the month of June/July,2019.



#### 4. **Vivekananda Overseas Education Scheme:**

The Executive Committee have been informed that under this scheme, fresh applications have been invited from 14-06-2019 to 31-08-2019.

Further the Executive Committee have been informed that in order to facilitate the eligible applicants who aspire to take admissions in the foreign universities during Fall season commencing in the month of August 2019, whatever applications received by 23-07-2019 would be put to Selection Committee for scrutiny scheduled to meet from 24-07-2019 to 27-07-2019.

#### 5. **Veda/Shashtra Pandits Honorarium:**

The Executive Committee have approved the proposals relating to sanction of honorarium @2500/- rupees per month to the following Veda/Sastra pandits of above 75 years of age, with effect from 01-07-2019.

- 4) Sri Mulamalla Rajamouli Shastri (79), Kolhaur (V&M), Nagarkurnool (D).
- 5) Sri Joshi Rama Shastri (82), solipuram (V), Ghanpur (M), Wanaparthy (D).



6. Request of Vedic Charitable Trust for Financial

Assistance:

The committee have discussed threadbare about the request of Veda Bharathi, a public charitable trust for giving an annual financial grant to undertake the task of preservation of rare chantings of Vedas in CD's, DVD's, Pen drives and Hard drives for making them available to play in temples and other cultural centers of high significance.


The committee have approved for giving a financial grant of Rs.1.00 lakh initially and with regard to extension of further grant it was opined that it should be done only after reviewing the performance during this year.

7. The Executive Committee have ratified the decision of Hon'ble Chairman with regard to sanction of Rs.5.00 lakhs (Rupees Five Lakhs only) in favor of Vedic culture Sahasra Chandi Yagam at Sri Saandrananda Swamiji Ashramam, Marrimuchala (V), Komuravelli (M), Siddipet (D) for conducting Maharudra Purashcharana Sahita Chaturveda Swahaakara Purassara Sahasra Chandi Yagam from 05-07-2019 to 09-07-2019.
8. The Committee have approved to sanction an amount of Rs.2.00 lakhs (Rupees Two lakhs only) based upon the request of Sri Joshi Gopala Sharma, Member, TBSP with regard to re-imburement of part expenditure incurred on conducting Athi Rudra Chandi Yagam at Solipuram (V), Ghanpur (M), Wanaparthy (D) from 19-04-2019 to 26-04-2019.
