MINUTES OF THE EXECUTIVE COMMITTE MEETING OF TELANGANA BRAHMIN SAMKSHEMA PARISHAD HELD ON 07.03.2022 AT 11.30AM IN THE OFFICE OF THE CHAIRMAN, TELANGANA BRAHMIN SAMKSHEMA PARISHAD, DHARMIK BHAVAN, BOGGULAKUNTA, ABIDS, HYDERABAD.

At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss certain agenda items and the following deliberations held.

1. Confirmation Of The Minutes Of The Last Executive Committee Meeting:

The Minutes of the last Executive Committee meeting held on 15.11.2021 have been read over and confirmed.

2. Construction of Viprahita Brahmin Sadan:

The Executive Committee have been informed about the latest stage of construction of Brahmin Sadan at Gopanpally (V), Rangareddy District. The Committee opined that the contractor and R &B Department who is the executing agency have to be reminded about the early construction of Auditorium so that same can be got inaugurated soon.

Similarly, under Brahmin Entrepreneurial Development Scheme of Telangana (BEST) the Executive Committee have been informed that in as many as (34) cases approved by the Executive Committee, the beneficiaries have not submitted the proof with regard to individual contribution towards

unit cost and as such subsidy could not be disbursed to them. The Committee have opined that all the (34) beneficiaries who failed to submit their part of contribution have to be heard personally, if necessary, by convening a meeting at the earliest, and they should be explained the guidelines of the scheme and to sort out the issue once for all.

Further, the committee have been informed that all the (226) beneficiaries who have submitted proof of individual contribution are considered for disbursement of subsidy into their Bank Accounts and that the same was under process.

3. Sri Ramanuja Scheme:

The Executive Committee have been informed that in respect of all the (21) cases which were approved in the last Executive Committee meeting, the fee amounts have been reimbursed by depositing the amounts into their bank Accounts

4. Vivekananda Overseas Education Scheme:

The Committee have been informed that under this scheme fresh applications have been invited from 05-01-2022 to 28-02-2022 and that till the expiry of last date as many as (235) applications had been received through online.

Out of (235) applicants, in the 1st spell as many as (100) applicants have been invited for the interviews by the State Level Selection Committee (SLSC) which was conducted from 21-02-2022 to 24-02-2022. The Executive Committee was informed that SLSC after conducting interviews to the applicants recommended (62) cases. In this regard

proposal has been placed before the Executive Committee for approval of (62) cases for issuing Provisional sanction proceedings for sanctioning of scholarship.

The recommendations of SLSC with regard to deferred and non-recommended cases as per Annexures from (II)(A) to (II)(E) were placed before the Executive Committee. The committee took note of the same and approved the proposals.

The Executive Committee have suggested to give an opportunity to all the (8) applicants figured in Annexure (II) (A) i.e. the list of applicants not fulfilled the mandatory criteria like obtaining valid scores in exams like GRE-260, GMAT-500, IELTS (Academic)-6.0, TOEFL-, 60, PTE-50 to submit valid score to get qualified for assistance under the scheme.

The Executive Committee have been further informed that the interviews for the balance (135) applicants would be conducted by SLSC from 21-03-2022 to 25-03-2022.

5. Brahmin Entrepreneurship Scheme of Telangana (BEST):

The Executive Committee have been informed that all the applications which were in full shape have been cleared upto the stage of interview in the month of December, 2021 and that the physical verification of interviewed and selected beneficiaries was being attended by Project Consultants with the assistance of TBSP staff as was done earlier.

Further the Executive Committee have been informed that the Government have ratified the decision of Parishad in engaging the services of Retired Officers of Industry Department as Project Consultants vide

G.O.Rt.No.168, General Administration (Cabinet) Department dated 27-01-2022.

The Executive Committee have been informed that as many as (425) cases were cleared by the aforementioned verification teams during the month of January and February, 2022 and that the list of (425) beneficiaries was placed before the Executive Committee for approval of their eligibility and to disburse an amount of Rs.12,81,43,304/- into their Bank Accounts as per the Government's guidelines. The committee perused the list and approved the said proposal.

The Committee have expressed serious concern over the monitoring of sanctioned units. In this regard, it was opined that the physical inspection of sanctioned units has to be resumed as was done earlier by the respective members of TBSP in the districts entrusted to them and it was instructed to circulate the file in this regard.

The Executive Committee have been informed that fresh applications under BEST scheme have been invited from 21-02-2022 to 31-03-2022. The committee have instructed that all the backlog applications under BEST scheme have to be cleared by the end of April, 2022 in all respects and interviews for the fresh applications have to be commenced thereafter.

Further, Executive Committee have decided to convene annual General Body meeting tentatively on 30-03-2022 to review the progress and to discuss about the way to take forward the schemes more effectively in future.

6. Vedahita-Honororium to Veda/Shastra pandits:

The recommendations of Vedic Committee to sanction of monthly honororium of Rs.2,500/- to Brahma Sri Kakirala Prabhakar Sharma (75), Mohammadapur (V), Alladurg (M), Medak (D) is agreed to and approved.

7. Audit and Accounts:

The statement of Audited accounts for the Financial Year 2020-21 is placed before the Executive Committee for approval and the same has been approved.

8. The request of M/s Gururaja & Co., Chartered Accountants, Khairthabad, Hyderabad – 500004 to continue to empanel their firm to act as Auditors of Telangana Brahmin Samkshema Parishad is considered and approved the proposal to continue them for a further period of (3) years.
