

**MINUTES OF THE EXECUTIVE COMMITTEE MEETING OF
TELANGANA BRAHMIN SAMKSEMA PARISHAD HELD ON
08.01.2020 AT 11:30 AM IN THE OFFICE OF THE CHAIRMAN,

At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss various steps to be taken after the issue of approving certain schemes of the Parishad.

**1. CONFIRMATION OF THE MINUTES OF THE LAST
EXECUTIVE COMMITTEE MEETING:**

The Minutes of the last Executive Committee meeting held on 26.09.2019 have been read over and confirmed.

2. Construction of Viprahita Brahmin Sadan:

The Executive Committee has been informed of the latest stage of construction regarding Brahmin Sadan at Gopanpally by exhibiting the Photographs in Annexure-II of Agenda. The members have been explained about the progress of construction.

During the discussion on Brahmin Sadan, a proposal was mooted for engaging the services of Sri R. Kondala Rao, a retired Engineer-in-Chief (PR Dept.) who has immense

experience in civil engineering works and working as an Advisor to the Govt. of Telangana (PR & RD Dept.) for guiding the Parishad on engineering aspects related to Brahmin Sadan. Executive Committee have approved the proposal to engage the services of Sri R. Kondala Rao, Engineer-in-Chief (Retd.), PR Dept. by paying an honorarium of Rs.20,000/- per month.

Construction of Aparajitha Bhavan at Khammam and Madhira towns:

The Executive Committee have been informed that the District R&B officer, Khammam District had sent estimates along with type design for the proposed Aparajitha Bhavan at Khammam town and at Madhira town of Khammam District to a tune of 75.00 and 73.00 lakhs respectively. The proposal has been placed before the Executive Committee for according approval to send it to the Government for according necessary permission as required under the norms of the scheme. The Executive Committee have accorded approval.

Renovation of Brahmin Parishad at Siddipet town:

The Executive Committee have been informed about the Brahmin Parishad building at Siddipet and its present condition as noticed during physical inspection by the Chairman, TBSP and Sri T. Harish Rao, MLA Siddipet and present Hon'ble Finance Minister in the month of June, 2019. The Executive Committee have been impressed with the fact that there is a need for renovating the said building in the interest of Brahmin Community of the District.

The Executive Committee perused the estimates to a tune of Rs.97.40 lakhs prepared and sent by District Panchayat Raj Engineer, PIU Siddipet towards additional works to be undertaken for the said building.

The Executive Committee have resolved to contribute a sum of Rs.50.00 lakhs out of total estimated cost of Rs.97.40 lakhs.

3. Vivekananda Overseas Education Scheme:

The Executive Committee have perused the recommendations of selection committee in respect of (90) applicants who were interviewed in the 2nd phase and approved the list of (58) eligible beneficiaries and directed the Member Secretary to issue sanction letters.

Apart from the above, the Executive Committee have also approved the proposals as per the list enclosed, for issuing sanction letters to (10) more students whose cases were deferred earlier and now processed for approval, in view of fulfillment of requirements as per the Government orders in vogue.

4. Brahmin Entrepreneurship Development Scheme of Telangana:

The Executive Committee have been informed that selection committee under this scheme had interviewed as many as (513) applicants who attended the interviews conducted in two phases during 04-11-2019 to 08-11-2019 and 09-12-2019 to 13-12-2019 and selected as many as (455) beneficiaries as provisionally eligible as per norms.

Further, the Executive Committee members have been informed that out of total (455) cases, as many as (208) had been got physically verified by the staff of TBSP and that they have been put up for approval. The Executive committee approved the list of (208) beneficiaries and directed the Member Secretary to get the subsidy amounts disbursed as expeditiously as possible.

The Executive Committee have also been informed that it has been decided to conduct 3rd phase of interviews from 23-01-2020 to 25-01-2020 and 27-01-2020 to 28-01-2020 for as many as (300) applicants registered through online during June 14,2019 to September 20, 2019.

5. Sri Ramanuja Scheme:

The Executive Committee have approved the proposals placed before them for reimbursing tuition fees in respect of (63) fresh and (19) renewal cases who had submitted required information and the documents till date.

6. Veda/Shashtra Pandits Honorarium:

The recommendations of the Vedic Committee with regard to sanctioning of monthly honorarium @ Rs.2,500/- to 3 (Three) Veda/Sastra pandits namely

1. Sri Gouribotla Narasimha Sharma (78), Pothareddy Peta(V), Dubbak (M), Siddipet (D).
2. Sri Venkata Satyanarayana Kompella (75), East Anand Bagh, Medchal -Malkajgiri, (D).
3. Sri Challapalli Subba Rao (82), Manuguru (V&M), Bhadradri Kothagudem (D).

Further Executive Committee have ratified the decision with regard to sanctioning of honorarium for the following (3) Veda/Sastra pandits on the recommendations of Vedic Committee.

1. Sri Challa Radha Krishna Murthy (90), Hyderabad (D).
2. Sri Gandambotla Rajayya (86), Medak (D).
3. Sri Kommera Raja Bapu Sharma (76), Jayashankar Bhupalapally (D).

7. Grant to Veda Patashala:

Executive Committee have accorded approval for the recommendation of Vedic Committee for giving Rs.2.00 lakhs (Rupees Two Lakhs only) to the following Veda Patashalas namely

1. Sri Vidhyamanya Vidya Peetam, Maldakal (M), Jogulamba Gadwal (D).
2. Sri Satya Shiva Gurukula Veda Patashala, Devpalli, Ranga Reddy (D).
3. Sri Maha Subramanya Veda Vedanga Vidya Peetham, Srinagar Colony, Hyderabad (D). Wherein as many as (12) students are learning Vedic education.

8. Request of Dhanvantari Foundation:

The Executive Committee have perused the proposal in respect of request made by Dhanvantari Foundation International for financial assistance to a tune of Rs.1.00 croe to meet the expenditure for rendering coaching to as many as (90) Brahmin IAS aspirants who got selected through a screening test. The Committee taking note of the circumstances explained by the said foundation for financial assistance, approved the proposal to send a request to the Government for


issuing orders permitting the Brahmin Parishad to render financial assistance to a tune of Rs.50,000/- per annum to each candidate taking coaching in the said institution.

- The Executive Committee has been informed that the application portal would be enabled from 27th January 2020 to 29th February 2020 to receive fresh applications under the schemes being implemented by the Parishad.
