MINUTES OF THE EXECUTIVE COMMITTE MEETING OF TELANGANA BRAHMIN SAMKSHEMA PARISHAD HELD ON 26.09.2019 AT 11:30 AM IN THE OFFICE THE CHAIRMAN, TELANGANA BRAHMIN SAMKSHEMA PARISHAD, DHARMIK BHAVAN, BOGGULAKUNTA, ABIDS, HYDERABAD.

At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss various steps to be taken after the issue of approving certain schemes of the Parishad.

1. CONFIRMATION OF THE MINUTES OF THE LAST GENERAL BODY MEETING:

The Minutes of the last General Body meeting held on 13.08.2019 have been read over and confirmed.

2. Construction of Viprahita Brahmin Sadan:

The Executive Committee has been informed of the latest stage of construction regarding Brahmin Sadan at Gopanpally by exhibiting the Photographs in Annexure-II of Agenda.

3. Vivekananda Overseas Education Scheme:

The Executive Committee has been informed that (54) applicants who have been selected as beneficiaries were given sanction letters on 18-08-2019 in a program attended by Hon'ble Speaker as a Chief Guest.

Further it was informed that the follow up action with regard to applications that were deferred/not recommended by Selection Committee was being taken, as detailed in the Action Taken Report as part of agenda.

It was further informed that in addition to (78) applications which were received by 20-07-2019 and processed for disposal by the Selection Committee as well as Executive Committee, another (90) applications have been received under this scheme from 21-07-2019 to 20-09-2019. The committee has been informed that these applications would be processed for placing before the Selection Committee during 2nd/3rd week of October, 2019.

4. Brahmin Entrepreneurship Development Scheme of Telangana:

The Executive Committee has been informed that under this scheme as many as (277) applications, which had been pending, have been processed and interviews have been conducted from 19-08-2019 to 23-08-2019 and 26-08-2019. Out of (277), as many as (158) applicants have attended the interviews. The Selection Committee recommended (138) cases as eligible as per the norms in vogue.

The Committee has been informed that out of (138) recommended cases the staff of TBSP could verify as many as (100) cases physically and after due confirmation with regard to their eligibility the list of (100) beneficiaries has been placed before the Executive Committee for perusal and approval.

The Executive Committee has approved the list of (100) beneficiaries for disbursing subsidy to a tune of Rs.2,87,14,757/-and directed the Member Secretary to

disburse the amount at the earliest into the bank accounts of the respective beneficiaries.

The Executive Committee have been informed that under this scheme as many as (2989) new applications have been received through online within the stipulated period between 14-06-2019 to 20-09-2019.

It was further informed that, given the huge number of applications, it has been decided to conduct interviews for all the aforementioned applicants in a phased manner by calling a minimum of 250 (Two hundred fifty) applicants in each phase and that the 1st phase would tentatively commence in the last week of October, 2019.

5. Sri Ramanuja Scheme:

The proposal for fee reimbursement to a tune of Rs.24,32,889/- to as many as (130) students who are pursuing various Post Metric courses like Intermediate, B.Tech, B.Pharmacy, etc. has been placed before the Executive Committee for approval, and the same has been approved. Member Secretary has been directed to disburse the amount sanctioned at the earliest into the bank accounts of the respective beneficiaries.

6. Veda/Shastra Pandits Honororium & Grant to Veda Patashala:

The recommendations of the Vedic Committee with regard to sanctioning of monthly honororium @ Rs.2,500/- to 2 (Two) Veda/Sastra pandits namely

- 1.Sri Inavolu Venkateshwarlu (79), Hanmakonda (V), Kazipet, Warangal (D).
- 2. Sri A.N. Subramanian (75), Malkajgiri, Medchal-Malkajgiri (D).

and Rs.2.00 lakhs (Rupees Two Lakhs only) grant to a Veda Patashala by name Sri Gnanaprasunamba Smartha Pathashala located at Chilukanagar, Uppal have been accepted by the Executive Committee and approval has been accorded for sanctioning the respective amounts.

Apart from the aforementioned, the committee have discussed at length about the monitoring of units sanctioned to beneficiaries under Brahmin Entrepreneurship Scheme of Telangana (BEST). The Executive Committee strongly opined that monitoring ought to be done in order to see that the primary objective of the scheme i.e., helping the BPL families to come up financially and to improve their living conditions, is achieved.

Further Executive Committee arrived at consensus with regard to taking the help of the Members of Telangana Brahmin Samkshema Parishad to monitor the sanctioned units in the respective erstwhile districts.

It was also decided that a programme will be held in Nirmal district in the last week of October, 2019 to bring awareness about the schemes of Brahmin Parishad and setting up of business units by the beneficiaries under Brahmin Entrepreneurship Scheme of Telangana (BEST).

The Executive Committee requested Sri Samudrala Venugopala Chary, Member TBSP and Special Invitee of Executive Committee to take up the responsibility of organizing the said programme at Nirmal on 23rd October 2019; for which he has consented positively.
