## Vivekananda Overseas Education Scheme for 2022-23

#### **Objective**:

This scheme is intended to enable Brahmin students to pursue the professional and other higher educational courses abroad, who are hitherto not able to make it due to financial constraint.

#### Scope:

This scheme is applicable for students of Telangana State covering all 33 districts, who secured admission for any Master's Degree course / Post-Doctoral Course overseas in top Universities for the academic year 2022-23 (Universities list is enclosed as Annexure-I).

# Eligibility, Amount of Financial Assistance, Selection Process, Disbursement:

As per the following G.Os issued by the Government in SC Development Department in respect of Ambedkar Overseas Vidyanidhi Scheme.

1) G.O. Ms .No.54 Social Welfare (EDN.2) Department, dt:28-06-2013.

2) G.O.Ms.No.66 Scheduled Caste Development (EDN) Department, dt:09-11-2017

3) G.O.Ms.No.74, Scheduled Caste Development (EDN) Department, dt:19-12-2017

Besides that

- The student and his/her both parents should belong to Brahmin community and parents should reside in Telangana State.
- The total family income ceiling limit (including the applicant) from all sources shall be Rs.5.00 lakhs per annum.
- Should have obtained admission in a PG course of minimum 18 to 24 months duration to get Master's Degree from a top University situated in the countries enlisted in one of the G.O.'s mentioned above.

- Students who have already availed benefit earlier will not be eligible.
- Should not have availed himself/ herself any amount from any other Government scheme for the same purpose

### How to apply:

Eligible candidates shall fill their applications online in the prescribed format (<u>www.brahminparishad.telangana.gov.in</u>)

Applicant should upload the scanned copies (in .pdf of maximum of 250kb size each)

- 1. Passport size photograph (in .jpeg format of maximum of 50kb size).
- 2. Applicant's Aadhar Card.
- Residence & Nativity proving certificates, Bonafide certificates from 1<sup>st</sup> to 10<sup>th</sup> class.)
- 4. Marks Sheets from SSC onwards i.e., Inter, Under Graduate, Post Graduate Courses.
- 5. Caste Certificate from Mee seva
- 6. Income Certificate from Mee seva.
- 7. Copy of the latest Income Tax assessment is to be enclosed provided the either of the parents or Applicant declared Income under IT Act.
- 8. TOEFL / IELTS /PTE/GRE / GMAT.
- 9. Bank pass book first page.
- Gap documents after completion of Graduation (Appointment letter, Resignation letter & Relieving letter)
- 11. I-20 / Admission Letter from the University.

**Note:** As for as income criteria is concerned the annual income of applicant and parents will be considered as family income. The following documents should submit.

- 1. Salary certificate of applicant & Parents (if they are employed)
- 2. Income certificate issued by Tahsildar
- **3.** IT assessment copy

All those documents shall be of current financial year.

**4**. GRE/GMAT/IELTS (ACADEMIC)/TOEFL/PTE(ACADEMIC) log in credentials have to be submitted

- **5.** Students pursuing Diploma, post Diploma, Advanced Diploma, Certificate, Vocational courses, Post-Secondary Education courses need not apply.
- **6.** Under ELP( English Language Proficiency) students who have secured admission based on Duo lingo, English medium certificate and pursuing in overseas universities need not apply if they have not taken GRE/GMAT/IELTS( ACADEMIC)/TOEFL/PTE(ACADEMIC)
- **7.** Students who have applied to Universities in Germany & France should submit documents in English also.
