ORDER:

In the reference read above, the District Collector, Suryapet has requested the Government to define the Economically Backward Classes (EBCs), in order to implement the Government Schemes like Kalyana Lakhshmi Pathakam etc in the Districts.

2. Government, after careful examination of the matter in detail, hereby clarify that the Other Communities (OCs) who are economically backward having the income source less than Rs.2.00 Lakh per annum in Urban areas and Rs.1.50 Lakh per annum in Rural areas are hereby defined as 'Economically Backward Classes' (EBCs).

3. The above mention definition of EBCs is applicable for all the schemes/programmes/other benefits being provided to the EBCs under Backward Welfare Programmes.

4. The Chief Commissioner of Land Administration /Commissioner for Backward Classes/all the District Collectors and District BC Development Officers in the State shall take necessary further action accordingly.
