MINUTES OF THE EXECUTIVE COMMITTE MEETING OF TELANGANA BRAHMIN SAMKSHEMA PARISHAD HELD ON 22.01.2019 AT 10.30 AM IN THE OFFICE THE CHAIRMAN, TELANGANA BRAHMIN SAMKSHEMA PARISHAD, DHARMIK BHAVAN, BOGGULAKUNTA, ABIDS, HYDERABAD.

At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss various steps to be taken after the issue of Govt. orders approving certain schemes of the Parishad.

1. CONFIRMATION OF THE THE LAST MINUTES OF GENERAL BODY MEETING:

The Minutes of the last General Body meeting held on 20.09.2018 have been read over and confirmed.

2. ACTION TAKEN REPORT ON THE ACTIVITIES OF TBSP:

The following Action taken report on the schemes of TBSP has been briefed to the members;

i. Construction of Vipraita Brahmin Sadan:

Administrator has been asked to explain the progress of Brahmin Sadan, who has informed the committee that around 6 acrs 10 guntas of land allotted by Government at Gopanapally, compound wall has been constructed by

spending Rs.1.60 crores. Rs.2.00 crores has been released for this purpose. Further it was informed that earlier administrative sanction has been given at Member Secretary level for Rs.11.00 crores and later when Government instructed to take Administrative sanction from Government in the prescribed format, proposals have been submitted for Rs.17.90 crores (including Rs.6.90 crores meant for Auditorium). Government directed to obtain techno-finance report to process the file. R&B Dept., has been requested to give the said report. Engineer-in-Chief informed that this report would be given in the 1st week of February 2019. As far as work progress is concerned the committee has been informed that the following blocks are under construction.

- Information Centre Block
- Seers Accommodation Block
- Toilet Block

The photographs showing the latest stage of construction have been presented before the committee.

After taking note of the facts the committee opined that construction of Brahmin sadan at Gopanpally shall have to be completed as quickly as possible; at latest before the end of May 2019.

 Committee resolved for construction of apara karma sadan on the land donated by Sri Madiraju Seetha Rama Rao at Khammam. Necessary plan and estimate will be prepared and put up before March 2019.

- In respect of Suryapet Brahmin sadan, in an extent of 1 acre land donated by Dr. A. Ramaiah., Chairman informed that Engineer-in-Chief R & B Dept., has been requested to prepare the type design and estimates for sending appropriate proposals to the Government. Member Secretary informed that Engineer- in-Chief has been contacted in this regard and that he assured to complete the work by February 2nd week.
- Chairman further informed that in Pragnapur, Siddipet District Sri. Phaninder Rao came forward to donate 1000 Sq. Yds. of land and to register the same in favour of TBSP and the Administrator went to Gajwel, in this connection. But document was not registered for want of certain land clearance certificates from Tahsildar and Grama Panchayathi. The efforts would be made to get the land registered before the end of the March 2019 duly fulfilling all necessary formalities.

The Administrator informed that all the District Collectors have been addressed to identify the Government land of not less than 1000 Sq. Yds. and to allot the same for construction of Brahmin sadans in all Dsitricts.

The Executive Committee observed that earlier certain District Collectors had sent proposals duly identifying the Government land for construction of Brahmin sadans and desired that same be verified once again and take necessary follow-up action.

ii. <u>Veda Pathashalas:</u>

The Committee has been informed that in addition to the existing 20 Veda Pathashalas, 3 new Veda Pathashalas have applied for grant of Rs.2.00 lakhs and that they had been referred to committee headed by Sri. Astakala Rammohan Rao, Member, TBSP, dealing with this subject, for verification and report. The report is yet to be received.

Further committee has been informed that proposal for amending the "one time grant" as annual grant had been sent to Government and that orders in this regard had not yet been received. It is informed that the same is being pursued.

iii. Vedic Students:

It is informed that 124 students have enrolled with TBSP and all are getting stipend of Rs.250/- per month. As far as disbursement of Rs.3.00 lakhs to the Vedic students pursuing Smartha study and Rs.5.00 lakhs to those pursuing Aagama, Krama and Ghanatha studies is concerned, the Chairman has proposed that certain amount has to be deposited in the name of the student, Who takes fresh admission in the form of fixed deposit, in consultation with Andhra Bank, Office of Commissioner of Endowments and as when the student leaves the institution after completion of the course, the student concerned would be entitled to get all amount of Rs.3.00 lakhs or Rs.5.00 lakhs as the case may be, after maturity

of the fixed deposit. In any case if the student leaves the institution in the middle of the course proportionate amount along with interest accrued there upon would be given to the student. The Committee has approved the proposal of Chairman and resolved to take necessary action accordingly.

iv. Sampradaya Vidyalaya:

The Chairman informed that for the year 2017-18, Rs.3.00 lakhs amount has been released and for the year 2018-19 amount will be released after getting necessary due report from the management of Sampradaya Vidyalaya.

3. To read and record G.O.Rt.No.2822, General Administration (Cabinet) Dept., dated 20.12.2018:

The Chairman directed the Administrator to read out the G.O.Rt.No.2822, dt.20.12.2018 and explain the contents. Accordingly, Administrator read out the said G.O., and the Executive Committee took a note of the same.

4. Veda/Shastra Pandits Honororium:

The Executive Committee has informed that in addition to 13 Veda/ Shastra pandits, recently 3 Veda/Shastra pandits who crossed 75 years of age have applied for honororium and they have been sanctioned honorarium of Rs.2500/- per month. In this connection, the members have opined that the present age stipulation at 75 years is too high and the same may be reduced to 57 years which is most likely to be fixed for old age pensions by the State Government from April 1st 2019 onwards.

Chairman desired that this issue may be taken up in the beginning of next financial year.

5. Vivekananda Overseas Education Scheme:

The Committee has approved the list of One hundred and Ten (110) including that of deferred cases for extending financial assistance under this scheme. The committee opined that all the absentee candidates should be given one more opportunity for interviews duly looking into the deferred cases once again thoroughly. The Member Secretary assured the same.

6. Sri Ramanuja Scheme:

The Committee approved 81 (Eighty One) cases and directed the Administrator to see that in all incomplete cases, the applicants be informed to submit the necessary documents through e-mail, SMS and telephone etc.

7. Brahmin Entrepreneurship Development Scheme of Telangana:

The Committee approved 42 (Forty two) eligible cases and directed that all the 124 cases for which interviews have been conducted recently should be verified physically. It is resolved that the distribution of cheques in respect of 42 cases be distributed through Hon'ble Speaker, Telangana Legislative Assembly in the first week of February 2019. The committee also opined that all the absentee candidates should be given one more opportunity for interviews. The Member Secretary assured the same.

8. Audit and Accounts:

The Chairman directed the Accounts Officer to present the status of Accounts. The Accounts Officer explained the budget allotment and expenditure incurred so far and also presented Audited Accounts for the year 2017-18. Committee authorised the Chairman to fix appropriate fee to the Charted Accountant Sri Guru Raja Rao & Co. for the year 2018-19, duly approving the audited accounts for the year 2017-18.

The Committee also directed the Member Secretary to send necessary proposals to the Government Finance Department for allocation of budget for the year 2019-20 duly mentioning the quantum of requirements for various schemes and proposals including administrative expenditure.
