MINUTES OF THE EXECUTIVE COMMITTE MEETING OF TELANGANA BRAHMIN SAMKSHEMA PARISHAD HELD ON 13.08.2019 AT 03:00 PM IN THE OFFICE THE CHAIRMAN, TELANGANA BRAHMIN SAMKSHEMA PARISHAD, DHARMIK BHAVAN, BOGGULAKUNTA, ABIDS, HYDERABAD.

At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss various steps to be taken after the issue of approving certain schemes of the Parishad.

1. CONFIRMATION OF THE MINUTES OF THE LAST GENERAL BODY MEETING:

The Minutes of the last General Body meeting held on 20.07.2019 have been read over and confirmed.

2. i. Construction of Viprahita Brahmin Sadan:

The Executive Committee has been informed that the construction of Information Centre, Seers Accommodation Block and Toilet Block is at finishing stage and the tender process for construction of Kalyana Mandapam has been finalised and the contract has been awarded to M/s. Narra Constructions Private Limited and that hopefully the construction would commence within a short period.

The Executive Committee perused the latest photographs of the site and took note of the same. Further it was urged that the site be inspected as frequently as possible to check up and ensure the quality in the work being done.

ii. Construction of Apara Karma Bhavan:

The committee has been informed that the District R&B officer, Khammam has been requested vide Letter No.24/TBSP/2017, dt.22-07-2019 to prepare the type design and estimates for construction of Apara Karma Bhavan at Madhira and the same is being pursued by the Madhira Brahmin Sangham who initiated the proposal.

3. Vivekananda Overseas Education Scheme:

The Executive Committee has been informed that from 24-07-2019 to 27-07-2019 the selection committee constituted by the Government as per G.O.MS.No.2822, GA(Cabinet) Department, dt.20-12-2018 has conducted interviews for all the 78 (Seventy Eight) candidates whose applications are received by 20-07-2019, to select the eligible among them in accordance with Government's norms.

The recommendations of the Selection committee as detailed below have been placed before the Executive committee for perusal and approval.

The Executive Committee has perused the recommendations of the selection committee and approved the same for giving sanction letters to the eligible 54 (Fifty four) candidates.

Further Executive Committee resolved that in respect of (3) applicants who did not obtain requisite marks i.e., 60% in the qualifying Bachelor course despite qualified in other aspects, a proposal should be sent to Government for relaxing the said criterion, so as to enable the Parishad to help them by extending financial assistance under the scheme.

Similarly, Executive Committee has urged to give one more opportunity to the absentees in the next phase of interviews to be conducted by the selection committee.

As regards deferred candidates the Executive Committee perused the recommendations of the Selection Committee in each case and approved the same duly instructing to help them out duly advising the applicants, wherever necessary, within the parameters of Government's guidelines.

4. Brahmin Entrepreneurship Development Scheme of Telangana:

The Executive Committee has been informed that the subsidy amounts have been disbursed into respective bank accounts of all the 159 (One hundred and Fifty Nine) beneficiaries under BEST scheme, whose list was approved by the Executive Committee in the earlier meeting held on 20-07-2019.

Further a list of 6 (Six) beneficiaries under this scheme who were kept on hold for want of further information has been placed before the Executive Committee duly obtaining the same and deciding their eligibility for disbursement of subsidy. The Committee has approved the same.

The committee has been further informed that it was decided to conduct one more phase of interviews through Selection Committee for the 257 (Two hundred and Fifty Seven) applicants whose applications have been pending; it is also brought to the notice of the committee that the Selection Committee is scheduled to meet from 19-08-2019 to 26-08-2019, excluding public holidays on 24-08-2019 and 25-08-2019.

5. Veda/Shastra Pandits Honororium:

The Executive Committee in the earlier meeting approved the proposals relating to sanction of monthly honororium of Rs.2500/- per month w.e.f. 01-07-2019 for the following 5 (Five) Veda/Sastra pandits.
