At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss various steps to be taken after the issue of approving certain schemes of the Parishad.

**1. CONFIRMATION OF THE MINUTES OF THE LAST
EXECUTIVE COMMITTEE MEETING:**

The Minutes of the last Executive Committee meeting held on 19.10.2020 have been read over and confirmed.

2. Construction of Viprahita Brahmin Sadan:

The Executive Committee have been informed of the latest stage of construction of Brahmin Sadan at Gopanpally (V) of Rangareddy District.

**3. Brahmin Entrepreneurial Development Scheme of
Telangana:**

The Executive Committee have been informed that (372) cases which were approved in the last Executive Committee

Meeting have been processed and subsidy amounts have been disbursed to as many as (371) cases leaving (1) case undisbursed due to certain additional information about their financial status received warranting reverification of the facts on ground.

Further, proposal of (390) cases in respect of which physical verification is completed have been placed before the Executive Committee for approval to disburse subsidy amount to a tune of Rs.9,68,25,523/- (Rupees Nine crores sixty eight lakhs twenty five thousand five hundred and twenty three only). The Executive Committee have perused and approved the proposal with a direction to disburse the subsidy amounts into the bank accounts of beneficiaries as per the usual procedure.

4. Sri Ramanuja Scheme:

The Executive Committee have approved the proposal for reimbursing the fee to as many as (33) students who have fulfilled the requirements as per existing guidelines.

5. Enhancement of Salaries to the Outsourcing staff:

The Committee have been informed that in Telangana Brahmin Samkshema Parishad office there are (4) Outsourcing employees namely

- (2) – IT Programmers
- (2) – Data Entry Operators (DEO)

and that they have been working diligently, carrying heavy burden of work with sincerity and commitment. They have been working for the last more than three years without any increment in their monthly emoluments. Considering their

sincere, and hard work, a proposal has been placed before the Executive Committee to give approval for enhancement of their existing monthly emoluments by Rs.3,000/- to each (Rs.2,000/- as canteen allowance and Rs.1,000/- as Transport allowance). The Executive Committee have approved the proposal and directed to pay the enhanced emoluments with effect from 01-12-2020.

6. Action Plan for the Year 2020-21:

The Executive Committee have been informed that for the Financial Year 2020-21, the government have allocated Rs.50.00 Crores under the head of Brahmin Welfare fund. Considering the availability of budget and funds, an Action-plan has been prepared and placed before the Executive Committee. Earmarking of funds basing on the requirement under each welfare scheme is shown in the said Action-plan. The Executive Committee have perused and approved the Action-plan, giving enough leeway to the Hon'ble Chairman, TBSP to make necessary changes in the quantum of funds under such and such scheme basing on the requirement of funds.
