At the outset, the Chairman TBSP welcomed the Members to the Executive Committee meeting of the Parishad and explained that this meeting is called for to discuss various steps to be taken after the issue of Govt. orders approving certain schemes of the Parishad.

The following schemes of TBSP has been briefed to the members;

i. <u>Brahmin Sadan:</u>

Brahmin Sadan at State Headquarters in Gopanpally, Sherlingampally (M), Ranga Reddy District is under construction. The Executive Committee was informed that the construction activity is briskly going on and that was expected to be completed by the end of May, 2019.

Similarly, as regards construction of Brahmin Sadan at Suryapet it was informed to the Executive Committee that in an extent of one-acre land donated by Dr. A Ramaiah, R & B Department has submitted proposals along with the type design and estimates of cost of construction @ 2 Crores which

was approved in the earlier Executive Committee meeting. It is further informed that these proposals had been submitted to Government for according necessary approval. Government orders approving the same are awaited.

The Executive Committee was informed that with regard to construction of Apara Karma building at Khammam in the land (475 Sq. Yds) donated by Sri Madiraju Seetharama Rao, the proposals had been sent to District R & B officer, Khammam, R &B Dept., with a request to prepare type design and estimates and that the same was awaited. Executive Committee took note of the same and urged to inspect the site as frequently as possible.

ii. Veda Patashalas:

Executive Committee has been informed that the following five (5) Veda Pathashalas have been granted Rs.2,00,000/- each with the approval of Executive Committee in the earlier meeting and disbursed the same by transferring

the amount into their respective bank accounts.

- 1) Sri Mattapalli Lakshmi Narasimha Swamy Veda Patashala, Mattapalli (V), Suryapet District.
- 2) Sri Gayathri Veda Smartha Patashala, Nadargul (V), Rangareddy District.
- 3) Sri Kanakadurga Veda Smasrkuta Patashala, Warasiguda, Secunderabad, Hyderabad District.
- 4) Sri Saradamba Veda Vidyalayam, Meerpet (V), Rangareddy Dsitrict.
- 5) Sri Venkateswara Vdiyaranya Veda Vidyalam, Boduppal (V), Medchal- Malkajgiri District.

iii. Brahmin Entrepreneurship Development Scheme of Telangana:

The Executive Committee has been informed that all the beneficiaries figuring in the earlier approved list of 106 (One Hundred and Six only) have been disbursed amount into their bank accounts.

Further the Executive Committee has approved fresh list of 141 (One Hundred and Forty One) beneficiaries for extending financial support who were selected by the selection committee and got physically verified by the Telangana Brahmin Parishad staff in the month of March, 2019.

Further the following issues have been discussed as table item

- (1) It is informed that as per the approval of Executive Committee in the earlier meeting an amount of Rs.3,00,000/- has been disbursed to Sampradaya Vidyalaya for the financial year 2018-19.
- (2) The Executive Committee approved the name of Rampally Narayana Sharma (84 years), R/o. Budhakalan (V), Bellampalli (M), Mancherial District, for giving honorarium of Rs.2,500/- per month under Veda Hita-Veda/Sastra Pandits Scheme.
