# Guidelines of Sri Ramanuja Scheme for 2018-19

Ref.: G.O.Rt.No.584 (GAD Cabinet) Dept., Dt.:24-03-2018

In the G.O. read above, Government of Telangana while approving Ramanuja scheme meant for reimbursement of fee paid by the Post Metric students of Brahmin community, directed that it shall be implemented on par with other students of the higher studies. Pursuant to the orders of Government, the G.O.'s pertaining to implementation of similar schemes in other departments have been got examined. Basing on these G.O.'s, which are issued fro0m time to time, the following guidelines have been framed.

- 1) Parishad has decided to implement this scheme for the benefit of students who belong to families of BPL category. The Annual income considered for categorizing BPL would be as defined in G.O.Ms.No.11, BCW(OP)Dept., Dt.: 05-05-2018 i.e., family income not exceeding Rs.2 Lakhs in Urban areas and Rs.1.5 Lakhs in Rural areas.
- 2) Under this scheme scholarship will be paid by way of reimbursement to the Brahmin students who are natives of Telangana state as per the norms prescribed by the Telangana Government from time to time.
- 3) The students who already availed EBC scholarship under general fee reimbursement scheme being implemented by the State Government are not eligible to seek benefit under this scheme.
- 4) For students pursuing Intermediate, D.Ed, HPT, TPT, Diploma in Pharmacy & Degree (B.A, B.Com, B.Sc, etc) Courses:

Brahmin students pursuing these courses are entitled for scholarship amount to a tune of maximum Rs.10,000 or the actual amount of fee paid whichever is less.

#### 5) For B.Pharmacy Course:

For B.Pharmacy students Parishad will reimburse the fee up to a maximum of Rs.31,000/- or the actual amount of fee paid whichever is less provided they get the seat under EAMCET convener's quota.

### 6) For ITI students:

For ITI students Parishad decided to reimburse the fee as follows For Rural Areas:

i) Engineering Trades : Rs.15,000/-

ii) Non - Engineering Trades: Rs.12,000/-

#### For Urban Areas:

i) Engineering Trades : Rs.16,500/-ii) Non- Engineering Trades : Rs.13,200/-

### 7) For Polytechnic students:

Eligible Brahmin students who have obtained an integrated rank in the ECET exam 2018-19 upto 1000 ranks will be eligible for full fee reimbursement. Otherwise if their rank is more than 1000 they will be eligible for reimbursement of up to maximum of Rs.35,000/- or the actual fee whichever is less.

#### 8) For Engineering Courses:

- a) The students who are pursuing B.Tech / B.E / B.Arch and M.Tech / M.E / M.Arch duly getting admission under Convener quota of respective Common Entrance Tests i.e., EAMCET, PGCET are alone eligible for scholarship under Ramanuja scheme.
- b) The Brahmin students who have obtained an EAMCET rank upto 10,000 will be eligible for full fee reimbursement and others will be eligible for reimbursement up to a maximum of Rs.35,000/- or the actual amount of fee paid whichever is less.

c) The Brahmin students who are pursuing M.Tech / M.E / M.Arch in any of the colleges listed under Annexure-I, II & III appended to these guidelines, are eligible for scholarship / fee reimbursement to a tune of maximum Rs.57,000/- or the actual amount of fee paid whichever is less.

d) TBSP has decided to extend the benefit of scholarship under this scheme to the Brahmin students who are pursuing Graduation, Post Graduation courses in Engineering in states other than Telangana state.

(As per Government Memo No.1611/SW.Edn.2/2011-9, dated: 17-08-2011)

In this regard the Member Secretary / Administrator Telangana Brahmin Samkshema Parishad will get the list of premier institutions displayed in the Parishad website.

## 9) For M.Pharmacy, Pharma.D Courses:

Brahmin students pursuing these courses are entitled for scholarship amount to a tune of maximum Rs.68,000 for Pharma.D Course and Rs.93,500/- for M.Pharmacy or the actual amount of fee paid whichever is less.

## 10) For MBA & MCA Courses:

Students pursuing MBA & MCA Courses are entitled for scholarship in the form of fee reimbursement to a tune of maximum Rs.27,000/-.

(As per G.O.Ms.75, Higher Education (EC/A2) Dept., Dt.:16-08-2013).

11) For P.G. Courses like M.A, M.com, M.Sc and Law courses like LA, LLB LLM and Graduate courses in Agriculture, Horticulture, Bachelor and Master courses in Veterinary Science, MBBS, BDS, BIMS, BUMS, BHMS, B.Sc Nursing, BPT, MLT, etc.:

The fee structure mentioned by respective Universities will be followed for determining the amount of fee reimbursement. (Similar practice is in existence in the other departments for Post Metric scholarship in respect of above courses).

### Candidates have to submit the copies of following documents.

- a) Caste Certificate obtained from Meeseva Centre
- b) Income Certificate obtained from Meeseva Centre after 01-04-2017
- c) Certificate from the Principal / Institution in the prescribed format (Enclosed as Annexure I).

- d) Student should have a Mobile number for receiving One Time Password for registration of app (Mobile number may belong to the student or any one of his/her family members)
- e) Consecutive 7 years study / bonafide certificates from 4th standard onwards.
- f) Furnish CET (Common Entrance Test) allotment order for CET courses
- g) If there is a gap in study by one student, by discontinuation on health grounds or any other reason, the place of residence of the gap period as given by the MRO critically determines as to know whether a local candidate or not.
- h) Latest Passport size photograph
- i) Aadhar card of the student
- j) Bank passbook first page
- The selection shall be conducted by the Executive Committee at the State level.
- The Chairman is authorised to make exceptions in the eligibility/ selection process depending upon the merit of the case and his decision will be final.
