Subsidy	Bank Loan/Others
80 % (for unit cost up to Rs.1.00 Lakh)	Balance as bank loan / individual contribution
70% (for unit cost up to Rs.2.00 Lakh)	
60% (limited to Rs.5.00 Lakhs for unit cost from Rs.2.01 Lakh up to Rs.12.00 Lakhs)

The Commissioner, BC Welfare, Telangana Hyderabad/ The Chief Executive Officer, TS Most Backward Classes Development Corporation Ltd., Hyderabad/ The Managing Director, Telangana Backward Classes Cooperative Finance Corporation Ltd and 11 B.C. Federations shall take necessary further action accordingly.
